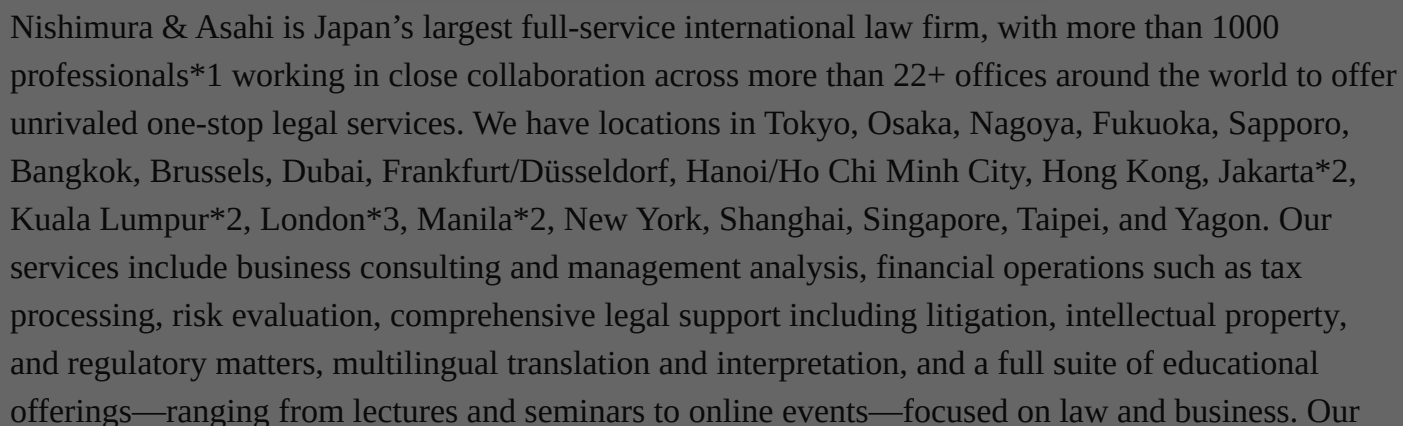

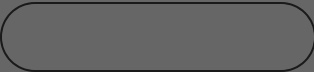

On June 29, 2026, the IP High Court ruled on a patent infringement lawsuit involving Amitiza® (lubiprostone), a chronic constipation drug. The case raises critical questions about the technical scope of medical use inventions and the extent to which patent term extension registration extends to generic drugs with different dosage strengths. The IP High Court's decision is expected to significantly shape future pharmaceutical patent practice in Japan. Amicus briefs are due by Sept. 30, 2026.
